Dear Mr. President,

As distributed generation companies, organizations and advocates, the members of Local Solar for All are committed to the clean energy transition that our country needs. We work every day to deploy rooftop and community solar and energy storage that deliver lower energy costs for households, communities and businesses, create good-paying jobs, enhance energy security in the face of both geopolitical risk and extreme weather, and protect human health and the environment by reducing greenhouse gas emissions.

We believe that the Administration's goal of carbon-free electricity by 2035 can be achieved with supportive federal and state policies that speed deployment of distributed generation technologies, reduce barriers and provide long-term certainty for investors, markets, consumers, and communities alike. According to modeling analysis, a minimum of 103 gigawatts of distributed local solar and 137 GW of distributed energy storage must be installed by 2030 to achieve your climate and equity goals at the lowest cost. Our members are working with the Administration to deliver on its goal of 5 million households powered by community solar systems and \$1 billion in energy bill savings by 2025.

In the State of the Union address, you urged Congress to cut energy costs for families by combating climate change. We stand ready to work with you, your Administration, and Congress to pass critical investments and incentives that support the installation of local solar, and energy storage and lower costs for consumers, help to revitalize local economies and protect human health and the environment. These policies, which the House of Representatives has already passed, also include funding provisions to expand energy equity and access for low- and middle-income families who are most vulnerable to high energy costs.

Our industry is growing, in part because of increased awareness of the urgency to combat the climate crisis. Passage of stable and predictable clean energy incentives would accelerate that growth and send a powerful market signal to investors, the industry, state legislatures, and regulators. More importantly, these policies would deliver on the key priorities of saving families money, producing power locally, creating family-sustaining jobs, addressing energy access and equity for low-and-middle income communities, and tackling the climate crisis. Local Solar for All is committed to working with you to ensure that the United States is on the path to carbon-free electricity.
